Dear Rt. Hon. Robert Jenrick

I am writing to you on behalf of those named below and our residents, with regards to the recent developments surrounding the ongoing works being carried out by Rathlin Energy at their site in West Newton, Mid Holderness, East Riding of Yorkshire.

20/04265/EIASCR - EIA Screening Opinion request - Proposed extension of the existing West Newton A (WNA) wellsite, test, appraise and produce from the two existing wells and drill, test, appraise and produce from up to six (6) new wells over a 25 year period.

Rathlin Energy submitted on the 17th December 2020 an EIA (Environmental Impact Assessment) Screening Opinion request to East Riding of Yorkshire Council. Following this submission East Riding of Yorkshire Council wrote back on the 20th January 2021 to say "the LPA considers that the development proposal would not comprise EIA development."

"Schedule 2 development (and changes/extensions thereto) is only EIA development if - in the opinion of the LPA - it is likely to have significant effects on the environment by virtue of factors such as size, nature or location." By East Riding of Yorkshire Council not setting out that this is an EIA development, they believe it will not have significant impacts on the environment.

In East Riding of Yorkshire Council's decision and reply they state that "it would not have the potential to have significant adverse impact on the environment". This we feel is truly wrong, the proposals by Rathlin Energy will in our opinion have significant impacts on both the local environment and also the wider environment. This can be clearly seen in their report which was submitted with the application (attached).

Section 3.6 Phase 6: Process Facility clearly shows that there will be 20 to 25 HGV movements per day, 24 hours per day, 365 days per year. These HGV movements will pass through and around many rural communities, and thus continuing further on into the East Riding until they reach their final destination. These actions are clearly going to have a detrimental impact on the environment with each vehicle polluting the surrounding area.

Possibly one of the safest and most environmentally friendly ways to transport hydrocarbons is via a buried cross-country pipeline, so this should be the only option considered.

Furthermore, there will be a significant number of HGVs travelling on country lanes, which are often used by the local community in their day-to-day business. The traffic will no doubt have a detrimental effect on horse riders, cyclists, dog walkers and school buses. It is estimated that over 180,000 tanker journeys will be made over the 20-to-25-year period. The works carried out and the movements of HGVs will be huge contributors to noise and light pollution as well as odours and vibrations.

I recently wrote to the Chief Executive of East Riding of Yorkshire Council on behalf of my fellow Ward Councillors and residents, raising the above concerns in a letter dated the 1st February 2021 (attached).

In Caroline's reply (attached) it was stated that "The issues raised in your letter are material planning considerations that can be taken into consideration by the council if a planning application is subsequently submitted for consideration". We believe this also to be incorrect. The concerns raised are those that affect the environment. These are the very considerations and concerns that should be taken into account when issuing a screening opinion on such a proposal as this one.

We therefore request that you issue your own screening opinion in the hope that you see that the proposals by Rathlin Energy do constitute an EIA development.
